Budget Changes

- Increases in the Circuit Court budget between the FY 04 Original Budget and the FY 04 Adjusted Budget are the result of a mid-year change in State law; the State now bills the County for 25% of all Law Clerk positions.
- Due to funding uncertainties, the Commissioners were unable to approve the planned 3% salary increase at the time of adoption in FY 04. The 3% salary increases for these agencies were added after the adoption of the Budget and are shown in the FY 04 Adjusted Budget. The FY 05 recommended budget includes a planned salary increase of 5%.
- The 4.40% increase in the Circuit Court budget is due to a \$45,000 increase in Bailiff's salaries. In FY 04, the State opened the new District Court; therefore a reduction to the bailiff salary line was anticipated, as the County was no longer responsible for providing bailiff services for the District Court. The salaries were underestimated for the Circuit Court operations by approximately \$35,000. Additional bailiff time is also anticipated for the new area renovated for Juvenile and Child Support hearings accounting for the additional \$10,000.

Highlights, Changes and Useful Information

- In FY 03, there were 7,348 Circuit Court filings, a 10.4% increase over FY 02 filings. Largest areas of increase occurred in criminal filings, jury trials emanating from District Court, juvenile filings and delinquency filings.
- The County is being reimbursed by the State for the salaries and benefits of the Standing Juvenile Master and the part-time Standing and Juvenile Master.
- In FY 03 the Orphan's Court examined over 2,200 estates and conducted 65 Court hearings.
- A total of 20,717 juvenile and adult offenders have been referred to the Volunteer Community Service Program since its inception in October 1980. Volunteer hours from October 1980 through November 2003 total 692,125. Calculated at a rate of \$5.15 per hour, the total value of the volunteer hours is \$3,564,443.75.

Description

The Circuit Court is a trial court of general jurisdiction, which handles major civil cases and serious criminal matters. The Circuit Court also has appellate jurisdiction over the District Court and certain administrative agencies. The Circuit Court has full common law and equity powers and jurisdiction in all civil and criminal cases within the County, and all additional powers and jurisdiction conferred by the Constitution and by law, except where, by law, jurisdiction has been limited or conferred upon by another tribunal.

Program Highlights

- Bail reviews are being conducted by video in order to enhance security in the transportation of inmates.
- The Domestic Violence Court Services Administrator coordinates all applications of domestic violence ex parte petitions and peace order requests in the Court system.
- The Pro Se Clinic arranges for the services of an experienced domestic violence attorney for income eligible persons who want simple advice for assistance in filing pleadings in domestic matters.
- In FY 03, there were 7,348 Circuit Court filings, a 10.4% increase over FY 02 filings. Largest areas of increase occurred in criminal filings, jury trials emanating from District Court, juvenile filings and delinquency filings.

Budget Changes

- Increases in the Circuit Court budget between the FY 04 Original Budget and the FY 04 Adjusted Budget are the result of a mid-year change in State law; the State now bills the County for twenty-five percent funding of Law Clerk positions.
- Due to funding uncertainties, the Commissioners were unable to approve the planned 3% salary increase at the time of adoption in FY 04. The 3% salary increase for this agency was added after the adoption of the Budget and is shown in the FY 04 Adjusted Budget. The FY 05 recommended budget includes a planned salary increase of 5%.
- The 4.40% increase in the Circuit Court budget is due to a \$45,000 increase in Bailiff's salaries. In FY 04, the State

opened the new District Court; therefore a reduction to the bailiff salary line was anticipated, as the County was no longer responsible for providing bailiff services for the District Court. The salaries were underestimated for the Circuit Court operations by approximately \$35,000. Additional bailiff time is also anticipated for the new area renovated for Juvenile and Child Support hearings accounting for the additional \$10,000.

- Included in the FY 05 capital outlay is the replacement of the walk-through metal detector units at the three entrances to the Courts facilities and new and replacement office equipment. In FY 04, the x-ray scanning machine was replaced.

Mission

The mission of this court is to see that children with needs are given the appropriate services to assist them and that all children who are involved in delinquent behavior receive intervention from appropriate agencies.

Description

The Juvenile Master functions as part of the Circuit Court for Carroll County but the Juvenile Master presides over the hearings. All delinquency, Child in Need of Assistance, and Child in Need of Supervision cases are heard in this Court. The Juvenile Court also handles some divorce cases and matters involving the custody and support of children. The Juvenile Court works closely with other agencies such as the Department of Juvenile Services, the Carroll County Department of Social Services, the State's Attorney's Office, the Office of the Public Defender and the Board of Education.

Program Highlights

- The Masters periodically handle Status Conferences in an effort to process cases more quickly.
- The County is being reimbursed by the State for the salaries and benefits of the Standing Juvenile Master and the part-time Standing and Juvenile Master.

Budget Changes

- Due to funding uncertainties, the Commissioners were unable to approve the planned 3% salary increase at the time of adoption in FY 04. The 3% salary increase for this agency has been made in the FY 04 Adjusted Budget.
- Generally, no growth was planned for operating expenses and salary expenses were planned to grow 5% between FY 04 and FY 05. Most budgets, including this one, were held at or near that level.

Mission and Goals

The purpose of the probate process is to provide a mechanism to transfer assets titled in the decedent's name alone, assure proper application of funds and protection of rights for creditors.

Goals include:

- Enforce the statutes for the assessment and collection of inheritance tax.
- Provide the framework for the proper distribution of the net distributable estate to the legal heirs.
- Conduct and preside over court hearings.
- Read and examine every estate of persons who die in Carroll County.

Description

The Judges of the Orphan's Court probate wills greater than \$20,000. Their functions include:

- Ensuring that all deceased person's wills are carried out in accordance with their desires.
- Protecting the rights of heirs in the absence of a will.
- Providing action on disputes over estates.

In addition, the Court approves all petitions for personal representative fees, attorney fees and funeral expenses in accordance with the laws of the State of Maryland. In FY 03 the Orphan's Court examined over 2,200 estates and conducted 65 Court hearings.

In accordance with the laws of the State of Maryland, the County pays the salaries and expenses of three Orphan's Court Judges. Salaries of the Orphan's Court Judges are set by law and may only change at the beginning of their four-year term.

Budget Changes

Generally, no growth was planned for operating expenses between FY 04 and FY 05. Most budgets, including this one, were held at or near that level.

Mission and Goals

Volunteer Community Service Program's (VCSP) mission is to offer a positive alternative to the traditional sentencing options used by the Courts in Carroll County.

Goals include:

- To ensure as many organizations and agencies as possible benefit from the services that VCSP provides.
- To perform court-ordered community service hours at private, non-profit organizations and government agencies.

Description

The VCSP, functioning under the authority of the Circuit Court of Carroll County, has been in operation since October 1980. VCSP interviews, places and monitors juvenile and adult non-violent offenders who have been referred to the program by the Circuit Court, District Court, Juvenile Court and the Department of Juvenile Justice as part of their rehabilitation.

Court ordered community service hours must be performed at private, non-profit organizations and government agencies. The VCSP continues to operate its Sunday work crew. This crew, staffed by community service workers and supervised by the Community Service Coordinator, works most Sunday mornings from 7:00 a.m. until 12 noon. The crew travels throughout Carroll County helping various County agencies and non-profit organizations with special projects.

Program Highlights

- A total of 20,717 juvenile and adult offenders have been referred to the program since its inception in October 1980 through November 2003.
- Volunteer hours from October 1980 through November 2003 total 692,125.
- Calculated at a rate of \$5.15 per hour, the total value of the volunteer hours is \$3,564,443.75.
- In 2003, the Sunday work crew assignments included:
 - Cutting firewood at Camp Hashawha and Piney Run Park.
 - Picking up trash around the lake at Piney Run.

Budget Changes

- Due to funding uncertainties, the Commissioners were unable to approve the planned 3% salary increase at the time of adoption in FY 04. The 3% salary increase for this agency has been made in the FY 04 Adjusted Budget.
- Generally, no growth was planned for operating expenses and salary expenses were planned to grow 5% between FY 04 and FY 05. Most budgets, including this one, were held at or near that level.
