

Overview of Public Schools CIP

The Public Schools Community Investment Plan (CIP) includes school construction, additions and modernizations, as well as other school related projects. For more than a decade school construction has been primarily funded by impact fees, dedicated income tax revenue and State funding. As we move into more troubled economic times, impact fees have dropped, State funding is at risk to be reduced and as a result there is a greater reliance on income tax to fund capital projects.

Developing the school construction plan is a complex process involving the Board of Education's plans, priorities and requests, enrollment projections, redistricting plans, and projected development. Historically, the County generally provided funding for three-quarters or more of the school CIP. In the current plan the county is providing eighty-five percent.

School capacity, modernization and funding to pay the debt service on existing and planned schools, dominates the FY 10-15 CIP. Overcrowding in the South Carroll area is addressed with a planned addition/modernization at a middle school and a planned elementary school. An addition/modernization at Mt. Airy Middle School is planned for design in FY 11 and construction in FY 12 at a cost of approximately \$38 million. State participation on this project should be about \$9 million. A new elementary school, at a cost of approximately \$31 million, is planned for the south east area of the County with design in FY 15 and construction outside the six-year plan in FY 16.

There are several other notable projects under construction. Manchester Valley High School is a \$79 million project scheduled to be completed in August of 2009. This school was constructed to alleviate overcrowding in the northern part of the county. The county is providing funding for the construction of a \$30 million fine arts addition to South Carroll High School and for the replacement of the HVAC system at Westminster High School. Due to the size and complexity of this system, it is expected to cost \$33 million and is expected to take three years to complete.

Even with the \$200 million included in the plan, everything could not be done. The Board of Education in recent years has identified a number of needs that have no existing or planned funding including:

- Construction of a new Career & Technology Center
- Charles Carroll Elementary School modernization
- William Winchester Elementary School modernization
- South Carroll High School modernization
- Westminster West Middle School modernization
- Westminster East Middle School modernization
- Eldersburg Elementary School modernization
