In the event that my submission wins first place in The Maryland Wine Festival® 2012 Poster Design Competition, I certify that it is my original art work, and I hold all intellectual property rights in the work; the work has not previously been used for any purpose; the work is free from any claims of libel, defamation or invasion of privacy; the work is free from all liens, claims and encumbrances of any kind; that I have not copied, based, or taken from any other work of art of any party; that no part of my submission is in the public domain; and that no other art works have been produced which are based in whole or in part of my submission. I hereby agree to execute the necessary Agreement to convey my ownership interests and all intellectual property rights I may have in my submission as its creator to the County Commissioners of Carroll County, MD, within ten (10) days of notification by the Carroll County Farm Museum. The conveyance shall be executed through an Agreement provided by the Carroll County Attorney's Office, which Agreement shall contain certain guarantees, warranties, and indemnification. Failure to transfer my ownership interest, including all intellectual property rights, within ten (10) days of notification will result in disqualification of my submission.

The Poster Design Competition is open to Maryland residents only. The winning design will be reproduced on posters, t-shirts, brochure covers, and other promotional items to publicize the The Maryland Wine Festival® at the Carroll County Farm Museum on September 15 & 16, 2012. The winning artist(s) will receive a check for \$1,000. The five (5) Honorable Mention winners will receive two (2) free passes to The Maryland Wine Festival®.

COMPETITION RULES

Criteria for submission of design is as follows (any criteria not met will disqualify entry):

1. All two-dimensional media is acceptable, including paintings, drawings, collages, photography, computer generated designs, etc. To see past winning posters, visit the Museum’s website: www.carrollcountymuseum.org.
2. All submissions shall be **original** works of art that have never been used, copied or published before for **any** purpose. Artist must hold all ownership interests in the design submitted including all intellectual property rights. Design submitted must be wholly original in all respects and may not be based on or taken from other works of any party nor may any part of the submission be in the “public domain.” No other art works may have been produced which are based in whole or in part on the submission. All submissions must be free from any claims of libel, defamation or invasion of privacy. All submissions must be free from any claims, liens, or encumbrances.
3. All participants must be at least **21 years of age** and be a **Maryland resident**.
4. Use of open bottles or the drinking of wine in an indulgent manner are to be discouraged. *Please note that if a flag is used in the design, it should be displayed in an appropriate manner; i.e., not touching the ground.*
5. The submission must be 18” x 24”, vertical orientation with accurate color, and as representative of the finished poster as technically possible. Posters should be mounted on stiff poster or mat board for display purposes. Submissions should be applicable to various formats such as brochures, t-shirts, and advertisements.

6. The design must include the following copy (required – please, no omissions):

PLEASE NOTE: “The Maryland Wine Festival®” is a registered trademark. Anywhere the exact words, “The Maryland Wine Festival®” are used, the ® symbol must also be used as shown.

7. Each artist may submit only one design entry. Collaborative efforts will be accepted; however, each artist must sign the release on the reverse side of this form. Artist must release County from any liability for loss or damage to submissions.
8. In the event your design wins, each artist must be prepared to sign an Agreement that will transfer **all** ownership interests in the submission and transfer and assign all copyright and intellectual property rights exclusively to the County within ten (10) days of notification. This Agreement will be prepared by the Carroll County Attorney’s Office for the winning artist’s signature and will include certain guarantees, warranties, and indemnification. Failure to timely execute the Agreement will result in disqualification.
9. Submissions **must** be received no later than 3:00 p.m. on Friday, March 16, 2012. Designs should be delivered or mailed to the following address:
