GENERAL RESPONSIBILITIES Operates equipment and vehicles to maintain County roads, bridges, and storm drains.

ESSENTIAL TASKS include the following; other duties may be assigned

Road Equipment Operator -

1. Operate trucks and light road maintenance equipment
2. Maintain roads, bridges and storm drains and perform snow removal operations
3. Maintain vehicles including completing vehicle inspection reports required by Department of Transportation
4. Maintain equipment and tools
5. Follow OSHA, MOSH, County Rules and Regulations, State Annotated Code and other federal, state and local laws
6. Report to work outside of normal work hours for emergency operations
7. Perform related duties as to specific assignments

Road Maintenance Worker

1. Operate various small equipment such as mowers, rollers, weed eaters, tampers, chain saws, air compressors/jack hammers
2. Perform maintenance duties such as digging, cleaning ditches and drains, shoveling and spreading blacktop/stone and chips, clearing debris, removing trash, sweeping streets, cutting weeds and brush, and mowing.
3. Assist drivers with clearing roadways during inclement weather and hooking up equipment and backing of trucks
4. Assist in repairing tire chains and maintaining equipment and tools
5. Report to work outside of normal work hours for emergency operations

EDUCATION AND EXPERIENCE

1. One year experience in heavy equipment or vehicle operation related to roads maintenance *
2. Successful completion of Carroll County REO I equipment test within ninety days of employment (**REO**)

* A comparable amount of training and experience may be substituted for the minimum qualification.

CERTIFICATES, LICENSES, REGISTRATIONS

1. Valid drivers license (**Road Maintenance Worker**)
2. Class A or B Commercial Driver's License with Air Brake Endorsement (**Road Equipment Operator**)
3. DOT (Department of Transportation) Physical Card (**both positions**)
4. State of Maryland Flagging Certification (or must obtain within six months of employment) (**both positions**)
