## **GENERAL RESPONSIBILITIES**

Operates and maintains water treatment facility for the County in accordance with Federal, State, and local laws.

## **ESSENTIAL TASKS** include the following; other duties may be assigned.

- 1. Collect water samples and administer tests to ensure safe water treatment operations
- 2. Perform inspection, mechanical maintenance and repair of facility equipment, pumps, and motors
- 3. Maintain equipment and tools
- 4. Complete routine paperwork such as time sheets and reports
- 5. Perform daily housekeeping and general maintenance of facility
- 6. Report to work for shift assignment including nights, weekends and holidays, and outside of normal work hours for emergency operations
- 7. Perform related duties as to specific assignments
