GENERAL RESPONSIBILITIES

Oversees and coordinates all duties and responsibilities associated with the operation of the Bureau of Utilities water treatment facilities in accordance with Federal, State, and local laws.

ESSENTIAL TASKS include the following; other duties may be assigned.

- 1. Perform supervisory responsibilities in accordance with the current Carroll County Personnel Ordinance, County policies and applicable laws
- 2. Manage and oversee water treatment purification process in accordance with Environmental Protection Agency (EPA) and Maryland Department of Environment (MDE) regulations
- 3. Compile and deliver composite reports from individual reports of subordinates required by management or government agencies
- 4. Manage maintenance program of potable water process equipment and other ancillary equipment used in water treatment facilities
- 5. Diagnose, analyze, and provide direction in equipment purchases and facility operations
- 6. Assist in the development of operating and capital budgets; work with State, Municipal, and local agencies in facility planning issues and projects
- 7. Maintain compliance with safety regulations in accordance with Federal and State laws
- 8. Report to work outside of normal work hours for emergency operations
- 9. Any employee may be identified as Essential Personnel during emergency situations
- 10. Communicate with managers, supervisors, co-workers, and others, maintains confidentiality; and represents the County
