ENTRY FEE: Adult Division: \$35 per shore angler, \$40 per boat angler

*Youth Division: \$10 - anglers age 12 & under

*Anglers age 12 & under **MUST** register in the Youth Division and are **NOT** eligible for Adult Division Prizes. Trophies for 1st, 2nd and 3rd Place (largest legal fish regardless of species) will be awarded in the Youth Division.

ANGLERS PLEASE NOTE:

- ★ Wristbands will be issued to anglers on day of tournament and must be worn while fishing and when presenting a fish at weigh-in. Anglers not wearing the wristband at time of fish weigh-in, will be disqualified.
- ★ A limited number of rental rowboats are available for an additional \$20.00 and are available on a reservation basis. You must bring lights (for dark hours) for rental boats. Piney Run Park **DOES NOT PROVIDE** electric motors for rental boats. **Once registered, Please call Piney Run Park at 410-795-5165 to reserve rental boat.**
- ★ Piney Run Park reserves the right to postpone the tournament until March 28, 2010 in the case of dangerous weather conditions. No refunds or credits unless tournament is cancelled.
