

# FISHING AND BOATING REGULATIONS AT PINEY RUN PARK

## FISHING

1. Fishing is permitted from authorized boats, piers, and shorelines during the park open season during park hours (sunrise to sunset): April 1<sup>st</sup> thru October 31<sup>st</sup> each year. Excluded are dam structures, the wildlife management area off White Rock Road, and any steep embankment. Written permission from land owners is needed to cross private property.
2. Fishing is permitted from the shore line ONLY from November 1<sup>st</sup> thru March 15<sup>th</sup> each year. **PLEASE NOTE: THERE IS NO FISHING ALLOWED AT PINEY RUN LAKE MARCH 15<sup>TH</sup> THRU MARCH 31<sup>ST</sup> EACH YEAR. This is due to preparations (fish shocking and tagging) for the Early Bird Fishing Tournament and Park Opening.**
3. **Manner of Fishing:** Rod, hook, and line only.
4. **Ice fishing is strictly prohibited.**
5. **Fishing Permits:** Anyone sixteen (16) years of age or older must possess a Maryland State Fishing license, which may be purchased at most Maryland sporting goods stores or online at the State of Maryland DNR website. A Piney Run daily use pass or season pass is also required.
6. Bank fishing on approved shorelines outside the recreation area and during park hours will be permitted proving one has a daily use permit or season pass and written permission from private landowners whose property one crosses to reach reservoir.

## BOATING

1. All boats MUST comply with Maryland State and Federal requirements for recreational boats. For information on these requirements call 410-269-3683.
2. All boats MUST be off the lake at the posted time. Times are posted at the gatehouse, boathouse, and at each boat launch.
3. Only electric motors are allowed on the lake.
4. All inflatable craft MUST have at least 3 separate air chambers. **NO INNERTUBES OR LOUNGING RAFTS ALLOWED.**
5. Swimming or diving from watercraft is strictly prohibited.
6. Boats are not permitted in the Wildlife Management Area at the northern end of the lake, off White Rock Road.
7. Boats must be launched from the 2 available boat ramps. A boat launch fee is charged at gatehouse. (see park entrance fees for fee schedule).
8. All persons born on or after May 1, 1972, must have a Boater's Safety Certificate to operate a motor boat.
9. A person may not operate or attempt to operate a boat while the person:
  - a. Is intoxicated
  - b. Is under the influence of alcohol and/or drugs

## RESERVOIR AND FISHERIES MANAGEMENT

1. **Wildlife Management Area** –off White Rock Road is protected and set aside for propagation of fish and other wildlife. Large pipes have been sunk in this area, and in other parts of the reservoir, by State Freshwater Fisheries personnel for the propagation of Channel catfish. Catfish need some form of cover in order to carry out their spawning activities. Excellent bird watching opportunities await at the Management Area, however, ALL observing must be done from White Rock Road.
2. **Reservoir Management** – The reservoir's fish are managed through the Maryland Freshwater Fisheries Division. Management activities include stockings, natural reproduction checks, creel census, fish habitat improvement, electro fishing survey, gill net survey, water quality data collection, and spot treatment of spiny naiad and nuisance aquatic vegetation. Fisheries personnel are consulted when yearly fishing events are planned to assure the populations will be maintained.
