Commissioners Set Date for Freedom Plan Public Hearing

Westminster, MD, Thursday, September 13, 2018 – Today, the Board of County Commissioners (BCC) completed their work on the Freedom Community Comprehensive Plan and voted to take the plan to Public Hearing on Wednesday, October 3, 2018. The hearing will be held at the South Carroll Senior Center at 7:00 p.m.

Today, the Board completed a review of all the remaining language in the plan to ensure consistency and completion. Additionally, the BCC voted to add a section to the plan entitled “Priority Implementation Steps” which identify six specific steps to execute the plan. At the end of the session the BCC voted (4-1, Frazier dissenting) to accept the changes discussed as the proposed Freedom Plan as well as voting (5-0) to move the plan to public hearing on October 3rd.
