Changes to Bridge Weight Limit Signs

The State Highway Administration has reassessed the policies on posting bridges for weight limits. Therefore, as part of the ongoing bridge inspection and maintenance program for the 153 County maintained structures, the Department of Public Works has reassessed the current bridge weight limit signs within the County. The findings of the assessment recommend that the current weight limit signs be removed from thirty-seven structures. Advanced signs will also be removed.

The thirty-seven structures will continue to be inspected as part of the bridge inspection program. Citizens are asked to contact the Bureau of Engineering with any questions. The structures to be affected are as follows:
